#### 2. <u>Brief Overview of NMB BANK Plc.</u>

NMB Bank Plc. ("NMB") is a full-service commercial bank incorporated in the United Republic of Tanzania. Through its 3 main business divisions: Retail, Wholesale, and Treasury, NMB provides a suite of financial services and products to retail customers, farmers, SMEs, Corporates, Institutions, and the Government.

Euromoney awards for excellence selected NMB as the "Best Bank in Tanzania" for 10 times in 11 years (2013-2023). The bank has also been named The Safest Bank in Tanzania for the year 2023 by Global Finance Magazine. NMB Bank was also awarded as the Best Blended Finance Partner in Africa for banks working with International Finance Corporation (IFC) of the World Bank Group in 2019.

#### 3. Information Request

Information is requested from your company to provide the below mentioned information to NMB Bank Plc.

This RFI is not an offer to purchase and NMB Bank is under no obligation to accept any proposals in this process and/or the subsequent RFP which may be issued hereafter. As this is a Request for Information only, no business will be awarded through this process. The submission should include in detail your proposed methodology, and preliminary program of expected activities. From the RFI and response and/or submissions thereto, NMB Bank will compile an RFP document, which will include business requirement document with an indicative schedule of activities and timelines.



In responding to this RFI, NMB Bank Plc encourages all RFI respondents to put their best effort into the construction and development of the proposal.

#### 4. <u>Project Scope</u>

## 4.1 Functionalities and general requirements:

Scope of work covers Design, Supply, Installation, Commissioning, and a comprehensive warranty Maintenance and Operation of Grid Connected Rooftop Solar Power system with module mounting structure, surge overvoltage protection, data logger with its sensors, and system monitoring via GSM/Ethernet.

The installation will be done at the NMB Head office building located in Dar Es Salaam Tanzania. The solar system is expected to substitute/supplement to the maximum of the available technology the main grid electricity supply of the building, and fully replace the backup generators use.

NMB has a rooftop area size of 1600 square meters where the installation is expected to be implemented without necessarily modifying the building current architecture.

The implementation is expected to be environmentally friendly, meeting NMB Bank Sustainability ambitions of embracing the use of clean renewable energy and improving energy efficiency and subsequently reducing greenhouse gas emissions.

## 4.2 Technical and Operational Specifications

## 4.2.1 General

The NMB HQ Building has TANESCO main grid supply as a primary source of power and three Generators as secondary sources. The secondary source is the backup to the primary source and works only when the primary source is experiencing outages.

The building consumes an approximate of 230,500kWH and 643kVA of power per month, and an average of 14,000 litres of diesel is used to power the generators in a month.

## 4.2.2 Operational

The system will operate as follows:

- i. The system will be an 'Grid Tied Solar system', supplying electricity directly to the building distribution board where both generators and TANESCO mains are connected.
- ii. The system should feed into the main board and will be protected against back-feed.
- All system components must meet guarantee/warranty terms and high-quality standards (provide certification) to ensure long-term sustainability of the PV system.
- iv. The local conditions must be taken into consideration (close proximity to the sea, strong wind, dusty surroundings).



- v. The system will be constructed such that a user can perform routine maintenance and replacing works, and a technician can easily perform system diagnostics or replace components.
- vi. The bidder will provide the most appropriate system integration, components, assembly, and packaging that meet all specifications.
