

Tender Notice: Disposal of Used Motor Vehicles

Introduction

Terms and Conditions of Sale

- a. The Used Motor vehicles are sold strictly on 'AS IS' and 'WHERE IS' basis. NMB is not responsible for undertaking any repairs that may be required.
- b. All Bids should be quoted in Tanzanian Shillings (TZS). Bids must be submitted with a fixed offer. Hand delivered bids may be deposited at the "TENDER BOX" located on the ground floor, near the reception desk of the NMB Head Office at the junction of Ohio/Ali Hassan Mwinyi Road.
- c. All bidders are required to deposit TZS 5,000,000 per vehicle intended to be purchased as a bid security through account No. 101-214010003 NMB HEAD OFFICE these will be refunded to all unsuccessful bidders within one (1) month closing date. Application not drawn in the prescribed format, not accompanied by TZS 5,000,000 deposit, not presented in the manner prescribed is liable for rejection.
- d. All applicants must indicate the proper address, emails, contact phone numbers and details of their bank account numbers in their applications in the format provided in NMB website <https://www.nmbbank.co.tz/tenders> or a physical form from a nearest NMB branch. The information is required to assist the bank refunding bid security deposit for unsuccessful bidders.
- e. The closing date for receiving bids is **1500 Hours on Monday 27th July 2026**. All bids will be opened in public at a tender opening ceremony to be held at the first floor, NMB HQ at the Ohio/Ali Hassan Mwinyi Road on the **same day at 1600hrs**.
- f. Successful bidders will be informed of the results immediately after the decision made by the Bank.
- g. Successful bidders should pay the TENDER/BID PRICE amount for the selected vehicle within 7 days of being informed of the results.
- h. The buyer/s is fully responsible for paying taxes and any other charges that may arise from the purchase of the Motor vehicles.
- i. The vehicle will be handed over to the successful bidder upon completion of the ownership transfer, which shall be the responsibility of the buyer.
- j. All documents for the Used Motor vehicles must be collected within 5 days from the date of full payment.
- k. NMB reserves the right to accept or reject bids and the right to make the final decision concerning this sale of Motor vehicles which may be due to but not limited to the following:
 - The buyer fails to collect any or all the assets within the six months after the payment has been received,
 - The buyer, in the judgment of the seller, has engaged in corrupt or fraudulent practices in competing for or in executing the contract,
 - The buyer has failed to pay the full contract price within 7 days of being informed of the results.
- l. All bids should be submitted in plain, sealed envelope(s), clearly marked 'Tender for Disposal of Used Motor Vehicles' and hand delivered to NMB Bank Head Office tender box bearing the following address.
